The member of the Authority, or his son, has succeeded in persuading other residents to sell to him. The implication is that they are inserting themselves as middle men and will then flagrantly inflate the price in order to sell on to the Authority. The land is held on a 500 year underlease, from 1817. The member of the authority, or his son, has succeeded in persuading other residents to sell to him. The implication is that they are inserting themselves as middle men and will then flagrantly inflate the price in order to sell on to the Authority, who are purchasing land in order to knock properties down to widen the river for flood protection. Mrs Sheppard's land is held on a 500 year underlease, from 1817. HACKNEY CARRIAGE FARES - Mr Cuffe Adams, new councillor, asks that cab driver Henry B. Woods, of 12 James' Street, licence number 23, be present at the next council meeting, so that he can be questioned about charging Mrs Cuffe Adams double the set fare. Woods tried to charge Mrs Cuffe Adams twice the going rate. Mr Cuffe Adams complained to him and paid him only the going rate of 1/- . 48

DOWN HOUSE, UPPER BRISTOL ROAD - planning permission for W.C., approved. 58

KENSINGTON GARDENS - planning permission for three new cottages, approved. 58. See Aug-21 Sep 1896 154a, deferred.

ST GEORGE'S PLACE, UPPER BRISTOL ROAD - planning permission for alteration to window, approved. 58

WALCOT BUILDINGS, 14 - planning permission for new shop front, not approved. 58

STANDARD BAKERY, LIVINGSTONE BUILDINGS, OLDFIELD PARK - planning permission for additions, approved provisionally. 58

CHARLES AUSTIN AND DAVID ALDERMAN, WHEELCHAIRMEN - Justices Clerk Mr Newton Fuller writes to Mr Moger that these two cab drivers have been up before the justices for fighting in the Abbey Churchyard and have been 'ordered to enter into recognizances to keep the peace'. He says 'that Austin has been previously dealt with for a similar breach of the peace'. 68. CABS AVAILABLE FOR BATH RACES NOVEMBER 1895 - Henry Gould, livery man of Lansdown Mews writes that he has 'made enquiries of Messrs Gould, Stuckey, Ames, Goldsworthy, Tall, Humphries, Davies, Page, Adams, Boyland, Basson, Frampton, Hillary, Pollett, Phillips, Tugnett, Wood and the Bath Road Car Company and I find they can supply upwards of 150 conveyances, consisting of Breaks, Landaus, Waggonettes etc. There are upwards of 100 Licensed Hackney Carriages and about 20 others, van proprietors etc.' He thinks a 'fair price for the two race days Breaks is 1/- to 2/-, each passenger and Carriages from 2/- to 3/- each passenger and for the Horse Show Breaks from 6d and Carriages 1/- each passenger'. 69

WALTER BLACKER, BUILDER, 13 CHARLOTTE STREET - writes on business paper with details of the barges seen emptying their waste into the river at Victoria Bridge. For ten days from Tues 7th January 1896 'I have seen about eight barges full of muck each holding about 25 tonnes emptied daily into the water. That would be about 2000 tonnes. I am told that the GWR Co have been doing this more or less for years. If that be true, then that would account for the increased height of the floods of late years. The muck seems to be very heavy. The stink from it while unloading is very unpleasant. Letter 108 was dated 17th January.
