<u>Urban Sanitary Authority (U.S.A.) Letter Book May-14 Jun 1897. This set runs from 1892-1905. They are catalogued to December 1897. The letter numbers are given at the end of each subject entry. Unless specified, all letters are addressed to Mr Moger, Clerk to the Urban Sanitary Authority. This letter book contains letters relating to the following subjects.</u>

WILLIAM WILCOX, ARCHITECT - of 1 Belmont, Bath. He was the County Surveyor of Somerset. He writes about starting work on the Electric Lighting Works. He has arranged for Mr Smith, who is Clerk of Works at the Pump Room but is under occupied to spend part of his time at the Electric Light Works for a guinea a week, providing the consent of Mr Bryden is obtained. 4

LYNCOMBE BOARD SCHOOL - Mr Argent Simmons writes to complain that the dust and refuse have not been collected from the school for at least a month. 5

DREDGING NORTH ARCH OF OLD BRIDGE - Mr Baster of Beechen Cliff writes to Mr Tuckett, Chairman of the Sanitary Committee that the time of year might be right for finishing the dredging under the north arch of the old bridge. He says the scenes yesterday with the boats there were worse than ever. 7

BATHEASTON MILL - Mr Spackman, Land Agent, writes to Mr Fortune, City Surveyor, that Mr Whittard will not be able to complete the removal of the dams by Wednesday evening next, so please can Mr Fortune keep the hatches up until Saturday. 8

ELECTRIC LIGHT BUILDINGS - a typed letter from J. May regarding various aspects of work at the new site. He has discussed these with various people. In conference with Mr Metzger and Mr Kolle, he reports on the arrangement of the main flue. In conference with Mr Wooster, he reports on the poor state of the boiler house roof, which Mr Metzger says needs replacing urgently. The site of the Men's and office W.C.'s also needs to be changed. Progress so far includes Mr Metzger clearing the coal bunkers away and moving all the coal. He is also making temporary condensing arrangements, so that the Raworth pump can be moved. No work can be done on the Engine House until this is done. Mr Metzger and his men are doing all of the clearing work and extra men need to be hired. The report ends by saying that a man fell over the wall on Friday and was drowned. Letter dated 1 May 1897. 9. COUNCILLOR JOHN, 15 OLD BOND STREET - at a meeting of the Council held 4 May 1897 Mr John was appointed as a member of the Finance, Electric Lighting, Fire Brigade and Surveying Committees in place of the late Alderman Charles Frederick Marshall. 11

LYNDHURST, CRESCENT GARDENS - planning permission for additions, approved. 21

CABMEN'S SHELTER, FOUNTAIN BUILDINGS - planning permission for this not approved. 21

RAILWAY HOTEL - planning permission for addition to smoke room, approved. 21

SUBSCRIPTIONS RAISED TO BUILD LIBRARY AND ART GALLERY TO CELEBRATE QUEEN VICTORIA'S RECORD REIGN - May 1897. Printed notice with tear off bottom portion for new subscribers. On the reverse is a notice announcing the building of an art gallery and library at the Guildhall to celebrate her reign. This was in accordance with the wishes of the citizens at a recent public meeting. 24

CALTON ROAD, 87 - Mr Fortune encloses an amended notice (not kept) addressed to Mr Lee or Ley, to abate the nuisance. 25, 187

STOTHERT AND PITT/ ELECTRIC LIGHT WORKS - letter about receiving approval of the contract drawings and starting work. He lists the sureties for the work, Mr Walker Pitt, Southstoke House and Mr Percy K. Stothert, Keynsham Manor. 27

DOLEMEADS IMPROVEMENTS - Stone King Solicitors write that they noticed in last night's paper that St John's Hospital were to sell their land at Dolemeads for £30, but this is wrong. The hospital offered to sell to the Authority for £35, provided that the Corporation provide and maintain a flight of steps to the river. 43

BARBED WIRE ACT 1893 - John Stone, Town Clerk, writes that Mr W. J. Caple of Moorfields House, Oldfield Park has infringed the act by placing barbed wire fencing on his land adjoining the footpath on Beechen Cliff. 44, 52, 72

RAGLAN PLACE, 7-9 - Mr Edwin Love, Quarry Owner of Odd Down, writes of the correspondence referring to these houses, asking what the surveying committee's surveyor will require. 51

RAILWAY PLACE - Mr Fortune, City Surveyor, writes that he has instructed that this portion of road be watered in future (this kept the dust down). 52b

RESERVOIR AT MONKSWOOD - W. C. Jolly of Home Lea, Lansdown, writes that the reservoir is practically completed and the Mayor has kindly consented to turn on the water on Wednesday June 2^{nd} 1897. Carriages will leave from the Guildhall at 12 and lunch will be provided on the ground. Invitation to Mr Moger. 58, 84

QUEEN'S JUBILEE MAY 1897 - James Williams of the Municipal Offices sends a circular to the effect that the city wish to add a pendant to the Mayor's Chain in recognition of the jubilee and also to provide the mayor with an illuminated manuscript of all of the subscribers. 64

GODDARD, MASSEY AND WARNER - discuss the improvement of the fans at the destructor and the cost of running it. 81, 210

NEW WOOD PAVING - the following streets will be re-laid with wood paving under loan: Kingsmead Street, Westgate Street, Pulteney Bridge, Argyle Street, New Bond Street, Quiet Street, Brock Street, Green Street, and Upper Boro Walls. Queen Square to be newly laid. From Charles Fortune, City Surveyor. 94. Also Jul-Oct 1897 83, where the tenders from Holmes of Bath and the Prismatic Paving Co. of Worcester are discussed. Woods to be considered are Australian Kauai and Archangel Deal. Prismatic Wood Paving Co. letter at 94, 96, 101 with picture of carbolized oak blocks. 96 also includes a newspaper clipping of the tender by the authority.
