SARAH M. PUCKLE, 2 MARLBOROUGH STREET - asks that the Authority send the dustmen to her tomorrow, as through the careless mess of the servant, the dust bin needs emptying again at once. The smell is very bad, she says. 1

EXTRA ASSISTANT NEEDED FOR CITY SURVEYOR – Charles Fortune, City Surveyor, writes that due to the very great increase in work he feels obliged to get an extra assistant and asks Mr Moger to grant this. 2a

LYDE HOUSE, SION HILL - planning permission for new staircase, approved. 2b

DRINKING FOUNTAIN AT CORNER OF BLOOMFIELD ROAD - planning permission deferred. 2b

MR SILCOCK, GROCER SHOP OWNER, HOLLOWAY - seeks planning permission for a new shop front. Approved. 2b

CHAPEL HOUSE, PARK STREET - planning permission for additions, approved. 2b

VICTORIA INFANT SCHOOL, GROVE STREET - planning permission for additions, approved. 2b

PULTENEY STREET, 64 - planning permission for additions, approved. 2b

DURLEY PARK ESTATE - planning permission, amended plan, not approved. 2b. See May-Jun 1897 21, 140, 158a

CRESCENT GARDENS, 4 & 5 - The City Surveyor writes about the line of the wall in front of these properties. A resolution of the Sub-Surveying Committee has directed that the wall be built in the proper line. He asks Mr Moger to communicate this to the Corporate Property Committee. 4

H. J. HARDING & CO., SOMERSET HALL - Printers. Short note on striking mauve decorated business paper. 8, 31

BERETON OR BEUTON AND THE FIRS, CLAREMONT ROAD - the author, whose name is illegible (G. V. Renuald?) writes from Clinton House, Victoria Road South, that these houses were built by his wife's father over 70 years ago. The road was first made by the Ground Landlords, the Rivers Estate. After completion of the houses he is informed, the Corporation made the path and put in the curb and the then owner of the property, W. Salter, paid the Corporation his share of the cost. It was then understood that the Corporation took over the road. The author wants to know why he is now being asked to contribute to the cost of the road. 9

SOUTHGATE STREET, 13 - the Inspector of Factories has visited from Whitehall and found the sanitary arrangements unchanged and unsuitable. He understands that planning permission for rebuilding the back of the property is about to be requested and asks for details. 10a. Loose in folder dated June 1897

GILES TANNER, BOLWELL'S BUILDINGS v U.S.A. - Mr Tanner's Solicitor Mr Phillips, of Chippenham, Wiltshire, writes that in 1892 the Authority purchased some land from Mr Tanner for street improvements and made a statutory declaration in support of the title. He would like a copy, as Mr Tanner died lately and his executors have sold cottages at Bolwell's Buildings. 11

REPORT OF MEDICAL OFFICER, STATUTORY HOSPITAL - Ernest Field M.D. reports that for the quarter ending June 1897 60 patients were treated. 48 had Scarlet Fever, 12 had Diphtheria. There were two deaths. A child aged 5 died from Scarlet Fever. A child of one and a half died from Diphtheria. Seven of the patients came from the Rural District, two with Diphtheria and the rest with Scarlet Fever. 18

THOMAS THEOPHILUS STONE, LAND AT DOLEMEADS - Mr Stone's Solicitor Thomas Vezey writes with details of the land. The strip from the railway arch to the property purchased from Mr Coward is 219 feet. The Corporation were at one time prepared to pay £100 for it. The portion of the land now measures 130 feet to the present boundary with the corporation. Mr Vezey now thinks £60 ought to go to his client and £40 to the other unnamed owner, a client of Messrs Little and Lyle. 58

H. G. BALL, HAIRDRESSER AND NEWSAGENT, 2 NEW WESTGATE BUILDINGS - says he has requested the men in charge of dustcart no.16 remove the dust through the house door, which is at the back, and not through the shop door. They refuse. Therefore it is usually removed during business hours and becomes a nuisance to customers and a hindrance to business. He asks if Mr Moger can help. 65

PAVEMENT LIGHTS AT 5 BATH STREET - The City Surveyor writes that the resolution to allow the light has been passed by the Surveying Committee. He asks Mr Moger to communicate with Mr Bowden, of 3 Westmoreland Terrace, about installation. 66b

LARKHALL BROOK - letters have been sent to Mr E. N. Sheppard and Mr Harper regarding nuisance at the brook. 69. For more on trouble at the brook in previous years see Feb-Jun 1893 233, 247 and Jun-Oct 1893 4, 277

W. H. SYMONS, MEDICAL OFFICER'S DAY - Mr Symons says that he prefers a meeting in the morning. He is not usually in Bath after 1pm. He dines at 2 and generally has some engagement at home afterwards. 80. See Oct-Dec 1897 15

J. H. HEATHMAN & CO., HYDRAULIC ENGINEERS - of 2 and 37 Endell Street, London WC. Writes to offer themselves for work on the electric light building. Highly decorated engraved advertising business letterhead, with 15 drawings of ladders and water pumps on front and back. 92

HENRY WEBB, 10 PARADISE STREET, WELLS ROAD - writes to complain about the rats and the smell under his parlour. He has had to close the room for over a month. He thinks the landlord has done his best but has not found the cause. He says Mr Montague's men found the cause last Monday but wonders if anything can be done to hasten its removal, for the sake of his wife and children. 98

The Medical Officer of Health had made two representations to the Local Authority. No houses were found unfit. No complaints were received by the Medical Officer from the public. One case involved negotiations with the owner but no closing orders were issued. 107

GREEN PARK VILLA - The owner Mr John Butcher refers to improvements to the property and to his tenant Mr Justice. 110a

MESSRS GERRISH & CO., DORCHESTER STREET - Edward Titley, Solicitor, writes for Gerrish to complain about the Corporation using Gerrish's premises to secure scaffolding for the new Electric Light Works and damaging their wall in the process. 110, 114

MRS STONE, SERVANT AT 3 MAIDA HILL WEST, PADDINGTON, LONDON - 'Sister Catherine', of this address, writes on behalf of her worker Mrs Stone. A letter has been redelivered addressed to Miss Allen of Bath, concerning Reginald Stone, Mrs Stone's eldest son who lives in Bath and was taken into the Statutory Hospital. Mrs Stone is the widow of a gentleman who died 17 years before, leaving no will. She has three younger children plus 16 year old Reginald. Her income is £40 per year. She therefore cannot pay the £8:12:0 asked by the Authority for the hospital stay. He appears to live with, or work for Mrs Stone's sisters. Sister Catherine (not her sibling) says the sisters ought to have nursed the lad themselves. They have made it clear that they will not pay the bill. Mrs Stone has lived with Sister Catherine for nearly four years and done her level best to provide for her children. 122 (three letters)
