He has lost out greatly through the recent floods and cannot do the work in the time specified. 28

MR H. C. STARK, PLUMBER - tender for fitting the flushing tanks and apparatus to the public urinals. Mr Fortune, City Surveyor, asks Mr Moger to prepare a contract as soon as possible. 31. Still waiting, 105

**WESTGATE STREET, 24, OPPOSITE** - displaced paving stone. Mr Fortune relays the story to Mr Moger. Something fell from the roof overnight and smashed the stone to pieces. He says that he had no other milk than was supplied by the Bath & Somersetshire Dairy that day as new milk. He was in charge of the shop from the time it was delivered until Mr Montagu came in. He is quite sure that nothing was done to lessen the percentage of cream. He saw the manager of the dairy who said that he could only account for the lack of cream by the constant dipping into it (which implies that it was kept in a churn and ladled out as required by customers in the shop). The dairy manager said that he had had more trouble keeping the farmers' milk up to the required percentages the last fortnight than in the whole of the winter. One from Kerry and Stokes, Solicitor for Colonel Jones of the Kelston Estate, saying that the site proposed by Mr Radford for filtration beds, in the horseshoe bend in the river, would be exceedingly objectionable to the Kelston Estate. 241.
