## Introduction



The church of St Vigor, Stratton-on-the-Fosse

From A Topographical Dictionary of England. published by Samuel Lewis (London, 1848): STRATTON-ON-THE-FOSS (St. Vigor), a parish, in the union of Shepton-Mallet, hundred of Kilmersdon, E. division of Somerset, 6 miles (N. N. E.) from Shepton-Mallet; containing 464 inhabitants. The parish comprises 1108a. 1r. 37p.; the surface is agreeably diversified with hill, dale, and woodland, and the soil consists chiefly of a red loamy earth, producing excellent pasture for cattle. The village is situated on the ancient Fosse-way, now part of the road from Bath to Shepton Mallet. Stone is quarried for building, and for repairing roads; a coal-mine is in operation, and ironstone and marl are found in abundance. The Bath market is principally supplied with butter from the dairyfarms in the neighbourhood. The living is a discharged rectory, valued in the king's books at £9.

11. 5½, and in the patronage of the Crown, in right of the duchy of Cornwall: the tithes have been commuted for £60, and the glebe contains about 40 acres.

The Anglican Church of St Vigor in Stratton-on-the-Fosse has been designated as a Grade I listed building. It reputedly dates from the years following the Conquest through Saxon and Norman times with the Manor of Stratton ultimately passing around 1204 to a Norman family called Sancto Vigore, who came originally from the village of Saint-Vigor-le-Grand, Normandy. It is assumed that the church was dedicated by the Sancto Vigore family during a time of rebuilding from a possible simple Saxon or Norman church. The church is thought to have undergone minor work in 14th century, much rebuilt 15th and 16th centuries with further rebuilding in late 18th century and restoration in the 19th century. The chancel is said to have been rebuilt in 1765 and the north aisle in 1782.

The Somerset Standard (of Sat 6 Nov 1886 p8) reported on a paper contributed to the Shepton Mallet Natural History Society by Dom Ethelbert Horne, of Downside, on St Vigor, Bishop of Bayeux "to whom the parish church of Stratton-on-the-Fosse is dedicated".

#### From the Western Gazette of Fri 4 Jun 1880: STRATTON-ON-THE-FOSSE

CHURCH RESTORATION.—The venerable and interesting church of this parish has just been restored by Messrs, Merrick and Son, of Glastonbury, at a cost of £600. Stratton is a parish lying a short distance to the east of the Mendip Hills, and contains, according to the last census, 345 inhabitants. The interior of the old edifice now presents a pleasing and inviting appearance. The architect was Mr. E. B. Ferrey, of London. The re-opening services after the restoration were held on Sunday.

Benjamin Ferrey (1810-1880) studied architecture under Augustus Charles Pugin and alongside Pugin's son Augustus Welby Northmore Pugin. He was diocesan architect for the diocese of Bath & Wells from 1841 and was responsible for the restoration of various churches in the area. His son, Benjamin Edmund Ferrey (1845-1900), was also an architect.

From *The Central Somerset Gazette* of Fri 23 May 1930:

#### INTERESTING RELIC OF GEORGE IV.

The Bishop of Bath and Wells has collated the Rev. T. C. Ibbotson, curate of St. James's. Taunton, to the rectory of Stratton-on-the Fosse with Holcombe, near Bath. Stratton church shares with Fulbourne, in Cambridgeshire, the distinction of being the only churches in England dedicated to St. Vigor. This Gaulish saint appears to have acquired his connection with Stratton-on-the-Fosse by reason of that manor having been bestowed by the Conqueror upon Geoffrey, Bishop of Coutances, not far from Bayeux, who bequeathed his property in Somerset to his French relatives (says the "Guardian"). Oddly enough, some hundred and fifty years after Bishop Geoffrey's death the manor of Stratton was owned by a William Thomas de Sancti Vigore. The organ in Stratton-on-the-Fosse church has had a curious history. It was originally made for George IV. for the Brighton Pavilion, but after his death it was bought for use in the old chapel of Downside Abbey.

There it remained until 1903, when the new Downside was finished, and was then bought by Stratton church. The original Norman church, which has an apsidal chancel, was much altered in the early Perpendicular period, but the existing chancel is relatively modern.

The name Vigor or Vigore in a slightly varied form is well known locally.



St. Vigor's Church forms a joint benefice with St. John's in nearby Chilcompton, and falls within the archdeaconry of Bath.

From *Primitive Sun Dials or Scratch Dials* by Dom Ethelbert Horne (Taunton, 1917):

91. (1) This dial is situated on the s.w. corner of the nave, on a quoin stone. It is 7 feet from the ground, the noonline is 3 inches in length, and the stylehole is  $1\frac{1}{2}$  inches in depth. The aspect is s. by  $3^{\circ}$  w. Type 3.

The mass line in this dial is sharp and distinct, and made at a different time from the other lines.

92. (2) A second dial is at the entrance to the s. porch, on the w. side. The height is 3 feet 3 inches from the ground, the noonline 3  $\frac{1}{2}$  inches in length, and the stylehole  $\frac{3}{4}$  of an inch in depth and about  $\frac{1}{2}$  an inch in diameter. The aspect is s. by 5° w. Type 3.

93. (3) A third dial is on a buttress between the S. porch and the E. end of the nave. It is 5 feet 1 inch from the ground, the radius of the outer circle is 4 inches, and the stylehole is 2 inches deep and  $\frac{1}{2}$  an inch in diameter. The aspect is S. by 5° W. November 3d, 1913.


No hour line can be seen on this ancient and badly worn dial. Outside the stylehole, at a distance of 4 inches, are the remains of two circles, one within the other, with  $\frac{3}{4}$  of an inch space between them.

(Dom Ethelbert Horne (1858-1952) was a Benedictine monk at Downside Abbey. In addition to his book on scratch dials he wrote a monograph on Somerset holy wells and was also involved in the archaeology of Glastonbury Abbey.)




The scratch dial on the southern wall.

The abode in the register shows that the occupants came mainly from various places in and around Stratton.



The age profile has 17.5% aged under 11 and 36.7% aged over 70.



#### Numbering Scheme

The burial ground has been divided into the following areas:

- S south and east of the church, a small number of memorials with numbers assigned in sequence
- W west and south of the church, a small number of memorials with numbers assigned in sequence
- N north of the church with rows is memorials. The identifiers use section letter, row letter

and plot number. The plot numbers start at 1 at the northern end.


#### **Burial Registers**

The register for 1783-1812 has pre-printed pages with columns for number, name, when buried, age and where buried. Entries are numbered until 1799, resuming in 1808. Ages were not entered consist-

ently until 1805. Some entries are annotated 'popelis', possibly as an indication of being buried by the parish or poor and therefore exempt from the tax on burial entries.

The post-2006 register is with the parish. In Feb 2020, this had 42 entries.

On the southern side of the church are some isolated old tombs, including some chest/altar tombs.






